Motion by Trustees Leinung/Schieren to approve minutes from the November meeting with edits. Carried

Discussion of Treasurer's Report:

The Library received a \$41.00 check from Hannaford

Treasurer Kelly has filled out and submitted a mandatory Dept of Labor form

The National Grid bill was again billed at the \$0.23 rate instead of the \$0.13 rate that was supposed to be used through January 2024. Treasurer Kelly will call to seek resolution of this issue

Treasurer Kelly reported that the current limit of \$500 for each of the two permitted credit cards, per the Credit Card Policy, is creating difficulties with the process for book ordering, given changes in how retailers are handling orders. A raise in the limit to \$1,500 per card was recommended. Motion by Trustees Schieren/Todisco that the Board amend the Credit Card Policy by raising the limit per card to \$1,500." Carried unanimously

There is still a balance for purchasing books in the 2023 budget. Interim Director Johnson will make some purchases by next Thursday, 12/28.

There is also money on the 2023 Overdrive line that can be spent Motion by Trustees Schieren/Leinug to accept Treasure's report. Carried

Director update - Kelly Kranick has resigned the position of Library Director due to health issues. The Board will begin seeking a new director after the first of the year. Mimi Johnson has agreed to be Interim Director.

Fundraiser Letter - The draft letter submitted by Trustee Berner was edited. President Teasdale will send the edited version to Board members and out to the public through Constant Contact. Board members should feel free to send out their own copies of the edited letter to potential donors.
